Minutes of the Regular Meeting of Members June 11, 2019.

The regular meeting of the Massachusetts Housing Finance Agency Employees' Retirement Board was held at the offices of the Massachusetts Housing Finance Agency, One Beacon Street, Boston, Massachusetts at 1:30 pm.

Stephen MacLellan, reviewed the system performance and noted that our System returned a 6.7% for the 1st quarter and 8.5% year to date. As of April 30th, the System's market value was \$156.5 million, an increase of \$10 million from the end of 2018. The increase was due to investment gains, mostly from an extremely strong start for equites. Mr. MacLellan noted that equities were up 18.6% for the year while international developed equities were up 13.4% and emerging market equities up 12.1%. Fixed income returns were positive. Investment grade bonds were up 3.1%. TIPS were up 3.5%, High Yield bonds up 9.7% and Emerging Market debt was up 6.8%. Real asset performance was also strong. Real estate performance was positive, up 1.8% y/t/d and natural resources grew by 12% and infrastructure rose by 2.7%. All asset classes were within their respective target asset allocation.

Mr. MacLellan also reviewed the fund transfers including the \$6 million for GQG.
